



## The Future of Swiss-EU Relations Webinar, April 7, 2022, 3-5 pm MET

In the shadow of Brexit, Swiss EU relations have stalled during the last decade. Bilateral relations failed to make progress, not addressing new and pressing issues. Ever since 2008, the EU called for an institutional framework including legal dispute resolution, and a more dynamic adoption of the *acquis* within the framework of more than 120 existing bilateral agreements. A Draft Framework Agreement of November 23, 2018 was controversially debated in Switzerland and failed to achieve wide support. The extension of free movement of persons to social rights, the reform of detached labour, and dispute resolution, in particular the role of the ECJ, have remained contentious. The Federal Council unilaterally withdrew from negotiations on May 26, 2021. A new agenda is currently being prepared and negotiations should resume this year.

While Switzerland is the 4<sup>th</sup> largest trading partner of the EU and mutual investments are strong, Swiss-EU relations, essentially defined by a constitutional system of direct democracy, often are not sufficiently understood. The webinar seeks to make a contribution to better understanding of the issues and discusses the prospects of negotiations and future relations between the EU, Member States with a country located in the heart of Europe. It will also address the potential implications of the Ukraine war on these negotiations.
